**RENTAL AGREEMENT:**

Lazy L & L Campground & Store, hereinafter called Lessor, hereby leases to above named lessee, and lessee hereby hires from Lessor the above described property on the following terms:

**RENT:** In consideration for the leasing of said property, lessee agrees to pay lessor as rent for said property, the sum indicated above, payable in advance.

**MAINTENANCE AND REPAIR:** Lessee shall maintain the equipment with property care and keep it in good repair and condition, so that such property shall not be injured or lost. Lessee assumes all responsibility for equipment while out of lessor's possession. All equipment lost or damaged will be paid for by the lessee at the retail replacement price. All damaged equipment which can be repaired will be repaired by lessor and the cost for such repairs will be paid by lessee.

**SUBLEASE:** Lessee shall not sublease leased property!

**RETURN OF PROPERTY:** Property shall be returned by \_\_\_P.M. on the same day rented. Failure to do so can result in forfeiture of deposit. Damages for losses will be paid for at this time. Failure to return equipment can result in charges of theft if not paid for properly.

**PRIVATE EQUIPMENT:** Lessor will not be held responsible for lost or damaged private equipment.

**INDEMNITY:** Lessees shall hold lessor, etc., (reference signed Release of Liability form(s)), harmless from all claims, actions, damage and liability proceedings, including attorney's fees, arising from or connected with lessee's possession, use and return of equipment.

**I also understand that any glass, Styrofoam or open plastic containers of 5 oz or less is not allowed on the river by ordinances approved by WORD in Comal County. Additional charges will be assessed for each subsequent trip.**
