In consideration of being allowed to participate in any way in the Lazy L & L recreational program, its related events and activities.

I, the undersigned, acknowledge, appreciate, and agree that:

The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and, I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the Company immediately; and,

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS Lazy L&L Campground & Store, their officers, officials, agents and/or employees, other participants, i.e., Water Oriented Recreation District of Comal County, Comal County, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used for the activity ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to Person or property associated with my presence or participation, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

**WARNING:** Due to rapids, swift currents, dams, trees and other objects and natural hazards, the Guadalupe River is dangerous and extreme caution should be exercised at all times. Life jackets should be worn at all times by all occupants.

I will inspect all craft and equipment issued to me and will not accept such unless it is in good condition. If I have never been canoeing, rafting, tubing or kayaking before, I will request a safety presentation. I am aware that several rapids, such as Dam(s) 1&2, Devil's Playground, Bad Rock Rapids, Chute, and others are rough and that prior to shooting any unfamiliar rapid, I will walk the shore and inspect the same.

I will wear sneakers/water shoes in order to protect me as best as practicable from any broken glass or sharp rocks I may encounter during my trip down the river.

I understand that all property along the river is private, and we shall not trespass. I will also be responsible for our own litter and return with it for proper disposal.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
